## **Identity and Statement of Educational Purpose 2019-2020**

The student must complete either side one or side two of this document, do not complete both sides.

**Side 1**. Appear in person at Moraine Park Technical College to complete this form in front of a designated Moraine Park Technical College official. **Do not complete this form before appearing at the College.** 

**Side 2.** If the student is unable to appear in person, please complete the information on side 2 of this form. Students not appearing in person must have their signature witnessed by a Notary and must provide a copy of an unexpired valid government-issued photo identification (ID). Notarized documents may not be photocopies or faxed. Only original notarized documents will be accepted.

## **Complete in Person at Moraine Park Technical College**

The student must appear in person at Moraine Park Technical College to verify his or her identity by presenting an unexpired valid government-issued photo identification (ID), such as, but not limited to, a driver's license, other state-issued ID, or passport.

The institution will maintain a **copy of the student's photo ID** that is annotated by the institution with the date it was received and reviewed, **and the name of the official at the institution** authorized to receive and review the student's ID.

In addition, the student must sign, in the presence of the institutional official, the Statement of Educational Purpose provided below:

## Identity and Statement of Educational Purpose 2019-2020 (To Be Signed in the Presence of a Notary)

If the student is *unable to appear in person* at Moraine Park Technical College to verify his or her identity, the **student must provide to the institution**:

- (a) A copy of the unexpired valid government-issued photo identification (ID) that is acknowledged in the notary statement below, or that is presented to a notary, such as, but not limited to, a driver's license, other state-issued ID, or passport; and
- (b) The **original** Statement of Educational Purpose provided below, **which must be notarized**. If the notary statement appears on a separate page than the Statement of Educational Purpose, there must be a clear indication that the Statement of Educational Purpose was the document notarized. **Notarized documents may not be photocopied or faxed.**
