Third-party documentation of this explanation is required. Academic credit is considered to be earned if the academic records show that the student completed any credit hours or clock hours. Please complete the bottom portion of this form and return to the Student Services Center with your letter.

Documentation will be reviewed by the Financial Aid Appeals Committee, and students will be notified of an official decision in writing. Providing all requested documentation does not guarantee student eligibility. If you did not earn academic credit at each institution attended and are unable to provide sufficient explanation and documentation of the circumstances that led to the failure(s), you will be ineligible to receive further financial aid. Students with a UEH that are determined to be eligible for aid may be subject to additional requirements.
