Borrowing student loans is a serious obligation, which must be repaid in full with interest. There are serious consequences if you fail to meet the terms of repayment. Carefully consider the amount of the loan funds you request, and please borrow wisely. Federal loans must be distributed equally over your term of enrollment. If you request a loan for \$3,500 for fall and spring you will be awarded \$1,750 for each semester, unless you indicate you would like it all for spring semester. Please make your loan request accordingly.
