Identity and Statement of Educational Purpose 2024-2025

The student must complete either side one or side two of this document, do not complete both sides.

Side 1. Appear in person at Moraine Park Technical College to complete this form in front of a designated Moraine Park Technical College official. **Do not complete this form before appearing at the College.**

Side 2. If the student is unable to appear in person, please complete the information on side 2 of this form. Students not appearing in person must have their signature witnessed by a Notary and must provide a copy of an unexpired valid government-issued photo identification (ID). Notarized documents may not be photocopies or faxed. Only original notarized documents will be accepted.

Complete in Person at Moraine Park Technical College

The student must appear in person at Moraine Park Technical College to verify his or her identity by presenting an unexpired valid government-issued photo identification (ID), such as, but not limited to, a driver's license, other state-issued ID, or passport.

The institution will maintain a **copy of the student's photo ID** that is annotated by the institution with the date it was received and reviewed, **and the name of the official at the institution** authorized to receive and review the student's ID.

In addition, the student must sign, in the presence of the institutional official, the Statement of Educational Purpose provided below:

Identity and Statement of Educational Purpose 2024-2025 (To Be Signed in the Presence of a Notary)

- (a) A copy of the unexpired valid government-issued photo identification (ID) that is acknowledged in the notary statement below, or that is presented to a notary, such as, but not limited to, a driver's license, other state-issued ID, or passport; and
- (b) The **original** Statement of Educational Purpose provided below, **which must be notarized**. If the notary statement appears on a separate page than the Statement of Educational Purpose, there must be a clear indication that the Statement of Educational Purpose was the document notarized. **Notarized documents may not be photocopied or faxed.**
