INSTRUCTIONS: The above student has certified on the Free Application for Federal Student Aid (FAFSA) that he/she is an unaccompanied homeless youth or a youth at risk of being homeless by answering yes to the following question:

The definitions of homelessness and unaccompanied are: "Homeless" means lacking fixed, regular, and adequate housing. You may be homeless if you are living in shelters, parks, motels, hotels, public spaces, camping grounds, cars, abandoned buildings, or temporarily living with other people because you have nowhere else to go. Also, if you are living in any of these situations and fleeing an abusive parent, you may be considered homeless even if your parent would otherwise provide a place to live.

"Unaccompanied" means you are not living in the physical custody of your parent or guardian.

We ask that you complete this certification for the above student as verification and return the form to the Moraine Park Technical College Financial Aid Office. The student's financial aid cannot be processed until this information is received. **If none of the options below apply to the student, student may check none of the above and fill out attached form.**
